In the event that I fail to submit a minimum of \$500 dollars to Girls in the Game by September 10, 2009, I agree and am aware that I will be held personally liable for this amount. In the event that I fail to submit a minimum of \$250 dollars to Girls in the Game by July 10, 2009, I agree and am aware that I will be held personally liable for this amount. **I further understand that if I withdraw from the race due to any reason, including personal injury, or otherwise, I will be responsible for the minimum pledge amount of \$500 dollars.** I understand that weather, emergencies or other issues of public safety may cause cancellation or postponement of the event. I hold TEAM GIG and Girls in the Game, its directors, officers, agents and employees harmless should such a cancellation occur, and I understand that no contributions, payments or expenses will be refunded.
